In the last month I started working with the Community of Port George and surrounding area on becoming more self sufficient after major storm events. District 8 – Councillor Gunn – as submitted

September has been a little slow for me, I had a little visit with the Province's health system and was put through in record time. Thank you to all those that had to deal with me and for the well wishes sent thereafter. September continued to be a month of saying goodbye to old friends. Otherwise, I attended the Town Hall meeting in Port Royal and the meeting in Paradise addressing the Waste Transfer Site. I would like to commend John Ferguson for persisting with attempting to inform people about the very complex issues we have had to learn about over the years of dealing with Valley Waste. It was very frustrating when people would not listen to responses to questions asked ... there was much to learn, and there is much for us all to learn yet.

At Committee of the Whole last week, we had a long discussion about how Council needs to unite with one another, and how we should stand tall with the decisions Council reflects upon, debates and ultimately makes. And then, we boldly present our choice to the public, knowing that we are informed and aware of what lies in front of us and how we may work with it.

I left thinking that day thinking we knew what it would take to have a united front, and that we had the clarity and understanding as Council and would speak as one, ensuring our Warden was the voice of the decisions made by the group as a whole.

This deeply held optimism lasted until I made it to the drug store, by which time it was pointed out to me the headline, Veteran Annapolis Councillor Marilyn's Humiliation "Council Made The Wrong Decision says Warden".

As elected Councillor for District 8 in the County of Annapolis, this is not what I wanted to see in print. Nor did it reflect what I had understood was the direction we were taking. I have spent the last 7 days having this issue addressed to me in person, I have received phone calls, and even had a copy of the magazine delivered to my house by concerned citizens. The question was: why was the Warden throwing Council under the bus?

I would like to remind the Warden that Councillor absenteeism (and what results from it) is determined by the Municipal Governance Act and is not assigned by the whim of Council, nor do "semantics" determine how it can be interpreted. While the public may do anything except that which is prescribed (or forbidden), government may only do that which is prescribed (or predetermined, by law). We took action as was required by law. And now we read that the Warden is willing to share details of our former Councillor's absences with press—including details he had not shared with us—and that he thinks Council made the wrong decision. And ultimately, the Warden voted against the MGA. The rest of us did not.

I believe that this rather uncomfortable topic needs to be addressed before the Warden continues to act as the voice or chairperson of Council.

Warden Habinski responded to Councillor Gunn as follows (Clerks note – The Warden asked that his response be transcribed in the minutes):

Thank you Councillor Gunn. I appreciate you raising that particular question. I'd like to clarify a couple of statements you made in your presentation. First, I provided no detail to the reporter about Councillor Wilkins' situation. In fact I skirted it entirely. He gleaned in fest from other sources. I was asked one question only — Why did you not vote with council? He was asking

about my own personal opinion as a councillor. As every councillor in this room is fully aware, we are entitled to our own particular opinions as councillors. I wasn't speaking on behalf of the municipality but he asked why did you vote against and I detailed the rationale for why I did. And I recognized at the time that my taking that position wasn't going to have any effect upon council's decision. I knew that I would probably be the lone voice. However, I have to vote my conscience on the issue. And I thought it was fair when the reporter asked me to explain my rationale for why it was that I hadn't agreed with the rest of council. Clearly, that was my opinion. I do not abdicate the right to an opinion by becoming Warden. And I was very careful not to speak as Warden of the Municipality on behalf of the Municipality as I made that comment. But I answered the question about my opinion and I have no qualms about doing so, But thank you for the question.

- District 10 Deputy Warden Roberts thanked TIR Area Manager Tony Harvey for paving Middle Road in Brickton, and Crisp Road up the mountain to Inglisville. It looks nice and is appreciated.
- District 5 Councillor Heming has been dealing with loose ends with forestry initiatives and the upcoming climate summit
- District 9 Councillor Sheridan encouraged all to seek out the webpage to make a donation towards the new primary health care centre being built at Soldiers' Memorial Hospital, Middleton. The Nictaux Fire-ettes Christmas Craft Sale is on November 3, from 10-3.
- District 4 Councillor McNeil had nothing to report.
- District 7 Habinski recounted arriving home after Committee of the Whole, to find company who was leaving. It was someone he knew from 40 years ago who had dropped in to visit.
