#### **Councillor Comments**

Municipal Council September 15, 2020

District 1 – Councillor Prout noted that schools have opened, and all seems quiet on the COVID 19 front. Watching the COVID numbers in our province. Farmers are finishing harvest from gardens, and Gravenstein apples are now available at the markets. The rain has been appreciated.

#### District 2 – Councillor MacDonald (as submitted)

I wish to express my thanks to the residents of District 2, for allowing me to represent you at your "Local Government" the last 4 years. Your wish for quality internet is approaching our doorsteps. Your wish for more jobs is also on the horizon with Gordonstoun Nova Scotia. My wish is to represent you at government another 4 years, to see these projects, and others, through to completion.

Beyond District 2, beyond the County of Annapolis, I am using my experiences of 35 years as a "Railroader" to help the Middleton Railway Museum realize their dream of obtaining a 1905 vintage Steam Locomotive in front of the museum.

And lastly, as a basketball coach of 30 years, and this year's High School Provincial Championship Team, I know the challenges of leaving ones comfort zone, to be the best one can be. So now I wish to applaud this 2016-2020 County Council, and Staff, for doing exactly that. For extending outside their comfort zone, to bring our County this Internet initiative and Gordonstoun Nova Scotia Private School, on top of all the other work.

- District 3 Councillor Fowler noted that election canvassing has been positive. He did not like seeing 'financial mismanagement' on some election signs as is not true. What a thing to say, with our past balanced budgets. He gave congratulations to Councillors Sheridan and Gunn for being acclaimed in their districts.
- District 4 Councillor McNeil also congratulated Councillors Sheridan and Gunn. He has been knocking on doors, so far so good. Has answered a lot of questions and hopes to serve again.

#### *District* 5 – Councillor Heming (as submitted)

In 1961, in honor of the right Hon. Vincent Massey former Governor General of Canada, CBC radio cosponsored with Massey College in the University of Toronto, what was to become the Massey Lectures. Those lectures enabled distinguished authorities to communicate the results of original studies on the subjects of contemporary interest. In 2004 novelist, historian and essayist Ronald Wright delivered his lecture entitled *A Short History of Progress*.

What stuck with me all the years since hearing Wright's lecture was the following statement he made regarding the climate crisis:

"The future of everything we have accomplished since human intelligence evolved will depend on the wisdom of our actions over the next few years."

It was this notion that motivated me to first run for council back in 2012. I wanted to test the idea that local government could add substantially to the body of wisdom that will somehow allow humanity to continue. I now believe that our municipality has demonstrated its willingness to do just this by setting out a strategy to:

- \* produce and distribute its own sources of food,
- \* produce and distribute its own sources of renewable energy,
- \* initiate its own placed-based educational system grounded in the humanities, volunteerism and mentorship
- \* provide safe, efficient and affordable housing,
- \* maintain clean air, water and uncontaminated soil,
- \* initiate a municipal ecological forestry strategy meant to preserve and protect significant forest land while creating local employment in through value-added industry,

... and all of these were to be understood in terms of climate change adaptation and mitigation as a direct response to citizens demand to declare a climate emergency.

I believe that the Municipality of the County of Annapolis has demonstrated such a possibility. Now, as I near the completion of my final term as a municipal councillor, I acknowledge there remains work to be done:

I believe the municipality must seek to:

- identify new sources of revenue through the establishment of progressive partnerships with business and industry,
- defend and litigate such revenue streams from more senior levels of government and selfish corporate interest that will inevitable try to build roadblock to such municipal innovation,
- it will require the municipality to find ways to redistribute wealth by raising taxes on those who can afford it and subsidize those who cannot.
- to build cash reserves far in excess of what is currently allowable by the province,
- and most importantly, the municipality must be brave enough to continue to hold the necessary conversations with our residents to produce the local wisdom that will lead to a more hopeful future.

#### District 6 – Councillor Morrison (as submitted)

I attended a meeting of Cornwallis Park Community Association on Monday evening. Good discussion. Some of the topics discussed were: comfort centre operations, types of sanitizers, electronic voting, the hospice to be located in Cornwallis park on land donated by ABCC, annual auction to be held October 3, apparent speeding in built-up areas by King's transit buses, appreciation for signs declaring the new speed limit as approved by Council, and resumption of some activities always in line with COVID-19 regulations

Upper Clements Hall will host an art show on 20 September from 2 to 4pm

Clementsport branch of the Royal Canadian Legion has started detailed planning for Remembrance Day ceremonies - in accordance with governmental and Legion Dominion Command regulations and guidelines.

Deep Brook/Waldeck Lions club held a successful Poutine lunch and yard sale on 5 September - good to see all the masks worn by all who attended.

District 7 — Warden Habinski noted that time moves slowly and fast all at once. This Council has addressed roadblocks and obstacles and with any wonder of making any progress. He had reviewed minutes from the last four years, and saw a dramatic picture of how far we have come. He listed some of at least 30 accomplishments, made outside the comfort zone of normal operations, adding we've come a long way, and despite difficulties, we have made a difference.

District 8 – Councillor Gunn thanked the folks of District 8 for allowing him to serve another four years. He has been fielding questions about the fibre optic build in District 8, and from Bear River regarding sidewalks – he will work for change there. Questions on roads and who looks after them. Roads out south don't always get looked after, between Queens and Annapolis Counties – he will work on that as well. Not everyone is excited about the new school and how it is financed. He has been asked how is council is meeting and getting anything done? We tackle the major problems, but small things don't get dealt with. There have been questions on cottage bins – they are being locked, will have to be dealt with. He is pleased to be in by acclamation. He noted he is not sure who will all return, but it has been a pleasure working with this council.

District 9 – Councillor Sheridan thanked residents of District 9, and looks forward to serving over the next 4 years. She wished everyone all the best, great to work with all, and added her best wishes to Councillor Heming.

District 10 – Deputy Warden Roberts reminded everyone about the next Lawrencetown Volunteer Fire Department Fish and Chips drive-through fundraiser being held on October 3<sup>rd</sup> & 4<sup>th</sup>, hoping it is successful. She had heard a lot about spraying in Inglisville and Paradise, and has met with the Village of Lawrencetown as spraying will take place in their watershed, which is a huge concern to the village. They have written letters to Ministers and MLA, and she encouraged residents to do the same. This is a serious thing, especially in a watershed area. Need to do all we can to get this stopped.

District 11 – Councillor LeBlanc was busy on the campaign trail, meeting old and new residents. Main concern is back to school, especially with small children with allergies or immune system issues. Not totally told to wear masks, little ones can only wear one for so long. This is a concern with parents with students in school (the little ones). She has received lots of productive information through conversations, with lots of new ideas. One recent concern is the people on the Kings Transit bus. She received an email from a citizen that rides the bus, who noted that some people who use the bus are not wearing masks. The writer is concerned that the bus driver is not telling people that masks are mandatory on the bus. She wished good luck to all on the campaign trail, and congratulations to those who were acclaimed. Also to Councillor Heming, a pleasure to work with him, great debates, will be missed. Hopes to still see him around.

#### **New Business**

#### Warden Habinski requested Deputy Warden Roberts to take the Chair (10:40 a.m.)

<u>Re</u>: <u>South Mountain Internet</u> – Warden Habinski noted it has always been the stated intention of the Municipality of the County of Annapolis to extend the reach of its internet project as rapidly as possible to every possible residence. The business case for our core backbone fiber build provides for expansion as revenues for the system increase year after year.

He acknowledged the concerns of residents whose homes are not included in the initial build. If the Municipality had an unlimited budget, the first phase would have included the entire municipality, but we had to work within our means.

He proposed the Municipality explore every option offered by provincial funding to bring true high speed internet to our residents as rapidly as possible. The Province may or may not agree to fund fiber to more remote communities, but we both can and should make the request.

#### **MOTION 200915.06** South Mountain Internet – Two-Part Funding Request to Province

Warden Habinski moved, seconded by Councillor Morrison, that the Municipality of the County of Annapolis submit a two part application for internet funding to the Province of Nova Scotia, requesting that the Province provide funding to extend fiber optic-based internet to remote communities including, but not limited to, Springfield, West Dalhousie and Milford; however, should the Province decline to provide funding for fiber-optic based internet, we would ask that they instead provide funding for a rapid deployment of true high speed wireless internet for these same communities. Motion carried unanimously.

It was noted that Councillors may submit specific roads or communities to the CAO to ensure they are all captured in the applications.

Warden Habinski resumed the Chair (11:03 a.m.)
