District 1 – Councillor Prout (as submitted)

The Port Royal Lighthouse Association continues their work with many volunteers, painting shingles, corner boards and much more in preparation for completing the beautiful Schaffner's Point Lighthouse in Port Royal.

Many calls continue with concerns and challenges faced in our communities from long grasses on the roadside and ditches that are densely filled with growth. All of this makes it concerning when driving

Fundy Tidal Park – spent a few hours there and chatted with locals and others. The contractor hired to clean sanitation facilities was a very dedicated young man, with a positive outlook on doing that work. Frank & Doras – very aware of the new park!

Cornwallis Park Community Association Hall – held an open house to meet and greet new Ukrainian citizens. Many came from far and wide to have a chat.

District 7 – Councillor Hudson hopes there was no serious damage from Tropical Storm Lee more than some loss of power. On July 28<sup>th</sup> he and the Warden presented grant cheques to community groups. He took his turn manning the County booth at the Annapolis Valley Exhibition; attended Ciderfest 8-10 September, which was well attended and very successful, with many activities including buskers, gymnastics, street parade, car show, games and demonstrations at Jubilee Park, and lots of food choices! Enjoyed watching the kids line up to eagerly see the reptiles. It was enjoyed by all.

### District 8 – Councillor Gunn (as submitted)

Thursday is the International Day of Peace, as is celebrated by the United Nations. The theme this year is Sustainable Development, and with that in mind I'd like to give an update on the progress of the Sustainable Forest Management our County is implementing in Greywood. Mersey Tobeatic Research Institute has completed the biodiversity assessment and have identified what can be sustainably harvested. The intent is to begin this fall. This is great news, and an excellent case of Leading By Example, and I'm delighted it's happening in District 8.

I joined the industrious group of people of the Milford Hall for a meeting and will be part of the fall clean-up crew and part of the kitchen staff of the upcoming Harvestfest. I also joined an event hosted by the Bear River Board of Trade promoting Bear River as a tourist destination and aims to combine the efforts of all community groups to do so. This is an excellent case of putting heads together with a common purpose, and I applaud their dedication and effort. Good things will come of this.

Upcoming is the community yard sale at Forrester's Hall in Clementsvale on September 30, and today is the opening parade of the Queens County Exhibition, which runs all week and is always a good time for local participants and those from neighbouring counties.

Saturday September 30<sup>th</sup> is the National Day for Truth and Reconciliation, and Kejimkujik National Park has advised that no regularly scheduled programming will be happening on this day of reflection and unification

I hope everyone's garden survived the storm and that you all enjoyed a bountiful growing season through the summer.

District 9 – Councillor Sheridan reported that Hurricane Lee affected the Nictaux Falls community park with lots of tree debris – thanks to community volunteers for putting it all back together. The Volunteer Expo this weekend on Saturday at Bridgetown Regional Community School – she is looking forward to the great opportunity to match volunteers with groups. The Middleton & District Lions are hosting a ticket auction on October 14<sup>th</sup>.

District 10 – Deputy Warden Redden – (as submitted)

I have had conversations with residents in the area of Springfield, including Ridge Road and Cherryfield Road about which recreation facilities they use. They indicated to me greater than 25 facilities outside of our county which they use on a somewhat regular basis. This does not include, "everything in Bridgewater" which is several more. I was surprised at the number of facilities in the area. It punctuated for me how much our residents work and play across municipal boundaries. In turn demonstrating how important inter-municipal co-operation is.

District 11 – Councillor LeBlanc spent time at the Port George Jamboree - it was busy! Good to see people attending from everywhere. Nova Scotia was hit again with another storm and we fared better than expected. She thanked REMO and Public Works who are always ready for these situations. #### Warden's October 2023 Update

I attended the opening session of the county-wide presentations on the draft county MPS and LUB, held at the Springfield fire hall. The STANTEC representative gave us a bit of history, outlined progress to date and replied to comments and answered questions. The citizens who spoke were informed and pressed for answers to their concerns. After the session, I dropped into the convenience store across the road and heard one of the attendees outlining the meeting to the clerk, thus beginning the expansion of the knowledge of local residents. As I made my way into the fire hall, I passed the two fire trucks outside that had been put there to allow us to use the main hall. My thoughts turned to the number of like fire departments throughout our county and how much gratitude we need to express to our volunteers. Our fire services study is now well underway and the report will be sure to arouse wide and deep interest.

The Annapolis County Volunteer Expo and Recognition Ceremony took place on 23 September on the grounds of, and inside, the Bridgetown Regional Community School. Both were eminently worthwhile activities that attracted attention, increased knowledge and will, I am sure, lead to continued benefits for all parts of our county. The expo tables were in an attractive arc that facilitated interchange between citizens and exhibitors, as well as between the exhibitors themselves. The volunteer recognition ceremony was well attended by those being honoured for their volunteerism, as well as their guests. And, it was a pleasure to have our neighbouring Towns (Middleton and Annapolis Royal) join us to recognize their own volunteer representatives. I enjoyed very much making the presentations to the county honourees. In the short number of seconds I had with each, I exchanged a few words and gave my congratulations. Everyone seemed to appreciate the occasion. County staff who developed this year's expo and recognition ceremony are congratulated and we look forward to a repeat in 2024.

I attended the hearing at the Annapolis Royal court house concerning the removal of an old Park Trust in Bridgetown. I was impressed by the manner of the judge, the involvement of county staff and, of course, the outcome that was in our favour.

A meeting attended by me, the CAO and others with representatives of the Save Our Old Forests organization proved informative and provided an example for the future as to how we might hear in detail the concerns and wishes of our local organizations.

The Planning Advisory Committee meeting held at Port Royal on the evening of 5 October can be deemed to be a productive event. Citizens delivered presentations on their views, advanced positions and were deeply immersed in the content of the draft report. The PAC members - Councillors and citizens alike agreed that the recommendations submitted to them needed a bit more clarification and amendment and thus returned it to the Habitation Community Area Advisory Committee for review.

In future, the Warden's updates will be part of Committee of the Whole.
