# **Councillor's Comments**

District 3 – Councillor Fowler noted disappointment from his communities on the lack of county-wide internet.

District 2 – Councillor MacDonald noted he had undergone day surgery last Friday, adding that Valley Regional Hospital is an excellent facility. He represented the County at the annual Federation of Canadian Municipalities conference held this year in Quebec City. He is also looking forward to the results of the RFP issued for internet provision. Yay Raptors!

District 11 – Councillor LeBlanc reported that the Three Rivers Community Centre Turkey Supper was a great success – sold out. Highest numbers of participants. Looking forward to another. Bloomington Road – a section has been paved; much better. Still a section not completed. Nasty potholes filled in.

The sink hole has been addressed in response to citizen concerns. Also at FCM, met lots of people. District 11 Town Hall was well received. Informative and good discussion.

- District 6 Councillor Morrison and other Councillors represented Annapolis County at the annual meeting of the Federation of Canadian Municipalities in Quebec City. Presenters included Prime Minister Trudeau, the Leader of her Majesty's Loyal Opposition Andrew Scheer, Leader of the New Democratic Party Jagmeet Singh, and leader of the Green Party Elizabeth May. The most educational presentation came on the last day of the conference, where four speakers contributed the following: premature death is on the rise; cigarettes; over-eating; lack of exercise; we need a culture of wellbeing; connect parks to people; know your neighbours, plant trees, plant flowers, tell stories, listen to storytellers; love of place; there must be a willingness to change; and re-imagine democracy with more inclusiveness. He also attended the Atlantic Provinces Library Association conference, where a repeat of these messages was heard: more social awareness needed, inclusiveness and accessibility are the major criteria to be considered in any decision henceforth - broadness and depth of approach and consideration needed. June 1st was the first annual Bridge to Bridge, 26 km yard sale, combined in a positive and cooperative manner with the Cornwallis Park Annual yard sale. Early July may see a oneday-per-week outdoor market adjacent to Basinview Centre. Deep Brook-Waldec Lions Club will host a drop-in opportunity to celebrate decades of service on Saturday, 22 June, from 1-4. The Cornwallis Park Community Breakfast will be held on Saturday, 13 July.
- District 8 Councillor Gunn acknowledged with thanks the incredible support he has received in the recent loss of his son Brogan. He attended a McGowan Lake stakeholders meeting regarding mainland moose and the new forestry model expected in future harvesting of crown land, noting that since the Lahey report, cuts will be selective. There is a need for buffers between clear cut land and land that isn't cut. He met with Premier McNeil to discuss funding complications for the Bear River comfort station. He also attend the annual meeting of the Medway Community Cooperative. He was excited to report that he had been contacted by CBC. The community of Bear River will be featured in an upcoming episode of Still Standing.
- District 10 Deputy Warden Roberts noted that this coming weekend is the Redneck Rodeo at the Annapolis Valley Exhibition grounds, and that the theme for the 2019 Annapolis Valley Exhibition is *Volunteers*.
- District 5 Councillor Heming's time has been given to the Dalhousie-Corbett Lake project, having receive at least 73 more letters which he has forwarded the Warden for response. TIR Area Manager Tony Harvey has been very helpful with Granville Road issues, adding that Mr. Harvey's timely response is appreciated.
- District 9 Councillor Sheridan reported that the part for the Nictaux playground has been received and it will soon be back in operation. More vandalism has occurred on the Scotney Trail, destroying all the benches. The neighbourhood is now keeping an eye on the trail, and will replace the benches one at a time. She advised caution if attending at Soldiers Memorial Hospital they are working on the canopy at the entrance.
- District 4 Councillor McNeil reported that he has been working with the community regarding the house in Granville Ferry house that was recently lost to fire. He added that he will be away from June 22 July 1.
- District 7 Warden Habinski had nothing to add to all the comments that had already been made.
