Re: C3 Water Supply Program (WSP) Bylaw – Repeal and Replace – Final Reading

MOTION 181016.02 C3 Water Supply Program (WSP) Bylaw Repeal and Replace – Final Reading

In accordance with first reading given on September 18, 2018, Deputy Warden Roberts moved, seconded by Councillor Fowler, that final reading be given to repeal and replace the *C3 Water Supply Program (WSP) Bylaw*. Motion carried unanimously.

Re: Annapolis Valley Exhibition Society – Councillor Appointments – Lift from the Table – it was moved by Deputy Warden Roberts, seconded by Councillor MacDonald, that municipal council lift the following motion from the table for discussion: *In accordance with the recommendation of Committee of the Whole, Deputy Warden Roberts moved, seconded by Councillor Fowler, that, in the absence of proof of insurance, municipal council discontinue the councillor appointments to the Annapolis Valley Exhibition Society*. Motion carried unanimously.

Re: Forestry Advisory Committee Recommendation (October 12th) – Councillor Heming noted that the following recommendation is to move forward with creating a climate forest in Annapolis County. The New Brunswick organization Belleisle Watershed Commission is creating a similar situation and have submitted an application to ACOA's Innovative Communities Fund. ACOA wants more regional buy-in in order to identify carbon credits onsite and to have someone to evaluate this. He added that NSCC COGS has this technology – surveying, drone surveillance, what is growing, soil content, etc. UNB and Dalhousie Universities have shown an interest, as well as proponents in Prince Edward Island.

In accordance with the recommendation of the Forestry Advisory Committee, Councillor Heming moved, seconded by Councillor Gunn, that municipal council direct the CAO to draft an application for council's consideration to ACOA's Innovative Communities Fund to establish a collaborative Maritimes Carbon Offset Pilot Project as one way to further council's intent to create a pilot climate forest in Annapolis County as outlined in Forestry Report 2018, and that an update on this application be provided at November Committee of the Whole.

The CAO added that he would like to streamline the process, and requested money to host prospective participants at a workshop to talk about this application to ACOA, so each participant has an idea where they fit in as we progress.

MOTION 181016.05 Maritimes Carbon Offset Pilot Project - Workshop Funding \$5,000 from Operational Reserve

It was moved by Councillor Gunn, seconded by Deputy Warden Roberts, to provide the CAO with a budget of \$5,000 from the operational reserve to conduct a workshop regarding a collaborative Maritimes Carbon Offset Pilot Project. Motion carried unanimously.

Councillor's Comments

District 3 – Councillor Fowler reported, that the pot-holes have been patched on Arlington Road and Brinton Road, and that walking lanes from Mountain Lea Lodge to the supervised apartments have been painted, thanks to TIR and Council for making this happen. He also reported that citizens had requested flags at the crosswalk at Granville Street/Chipman – he thanked staff for providing those in a timely manner.

District 2 – Councillor MacDonald represented the Annapolis Valley at Clan Donald Canada's AGM in Truro. He is excited about the leadership of the Forestry Advisory Committee and Council regarding forestry in Annapolis County. He attended the tour of Basinview Centre and the FundyYMCA. He also attended a tour of CFB 14 Wing Greenwood. He attended an NSFYM Workshop, participating in conversations regarding Tax Cap removal. He attended Thanksgiving dinner with family in Kings County, supplying pies made from Annapolis County apples and pears.

District 11 – Councillor LeBlanc found the September 27th CFB Greenwood 14 Wing tour very informative. On September 29th she attended the Three Rivers Community Centre grand opening – great work has been done on their entrance-way and they have future projects planned. On October 10th she attended the Basinview/YMCA tour. She was also present on October 13th for the signing of the Memorandum of Understanding with Suzhou Suqian Industrial Park (SSIP), and on October 25th at 430 there is a fundraising dinner at the Three Rivers Community Centre.

District 6 – Councillor Morrison was pleased to meet the guests from China on October 13th. He was present at the signing of the Development Agreement with Fort View which enables the owner to begin construction - likely in two weeks. There is a new District 6 publication called the District Rambler – he will add everyone to the mailing list. He ensured District 6 that they will get compost bins.

District 8 – Councillor Gunn attended the Queens County Exhibition last week, adding that many Annapolis County people work there. He has been fielding inquiries about when old green carts are

going and the new ones coming. He missed the tour of 14 Wing with the group but did go to the museum on his own. He attended the North Queens Fire Services banquet, where two service recognitions of 65 years were given. He was glad to attend a fall supper at the community hall in South Milford.

District 10 – Deputy Warden Roberts thanked the recreation department for providing canoes and kayaks at boat launch in Lawrencetown where 30 or more people attended. The Brickton community hall has received an accessibility grant to redo the bathrooms and doorway / ramp. She has spent time in the community dealing with various issues and is confident that everything will wind up soon.

District 9 – Councillor Sheridan reported a new gazebo at Nictaux Falls, where a free concert was held. She has attended local Lions suppers, the Basinview tour, and will be at the upcoming craft fair at the Nictaux fire hall.

District 7 – Warden Habinski reported that it was his pleasure to welcome the Suzhou Suqian Industrial Park (SSIP) delegation from China to sign a Memorandum of Understanding (MOU) on October 13th. Council has been working towards this MOU with our visits to China and it is opening for further partnerships. He was delighted that next fall the Mayor of Suzian attend here to sign the sister cities agreement.
