Re: Municipal Solicitor (*October*)

- A report for the month of October was circulated at the meeting. The Solicitor also noted:
- Discussions with S Hudson regarding tax sales,
- As disclosure the item on the agenda listed as Lunns Mill Beer Company this company was formed by his associate, noting some interest but no conflict.

It was moved by Councillor Fowler, seconded by Councillor McNeil, to receive the monthly report for information. Motion carried unanimously.

Councillor Comments

District 2 – Councillor MacDonald noted has been really busy, but has nothing significant to report.

District 11 – Councillor LeBlanc attended the Three Rivers Community Centre turkey supper – very festive! Building is phenomenal after all their renovations and has great atmosphere. On November 11th she laid a wreath at the Nova Scotia Community College Remembrance Day service. She noted this was well attended by people of all ages, from Veterans to toddlers. She encouraged all to support our communities and entrepreneurs by shopping locally.

District 6 – Councillor Morrison attended and laid a wreath at Royal Canadian Legion Clementsport Branch, which was followed by a lunch featuring the Gaels of Fundy Pipe Band. The annual Remembrance Day dinner was held that evening, where service awards and certificates of appreciation were presented. He was happy to note that paving has been completed on Hwy 1 from the Clementsport turn to the Bear River Bridge. He thanked Transportation and Infrastructure Renewal. He was sad to announce the passing of Rev. Adrian Potter, Chair of Clementsport Historical Society.

- District 8 Councillor Gunn attended three fundraisers a silent auction for a young couple in Bear River who lost their home; a ham and bean on first day of the month at the Forresters Hall (noting the courts and rinks in the back yard!); and a supper on Saturday at Maitland Bridge Community Hall. He attended Remembrance Day services at the Clementsvale cenotaph, a Bear River church service, and at the Bear River Legion. He noted that the Bear River Board of Trade met on November 21st to discuss common issues on both sides of the river, particularly water. It was nice to find out that local contractors (Nova Millwrights and Charles Stewart) did the majority of recent work on the causeway. Great job done three weeks early!
- District 10 Deputy Warden Roberts attended a fundraising 4H supper on Sunday at the Lawrencetown fire hall, raising \$6,000 which was matched by Scotiabank. She attended Remembrance Day services at Springfield (a small but quaint service); Lawrencetown fire hall; and Brickton Hall. She noted the Brickton hall has missed holding only two Remembrance Day services since 1918. On November 19th she attended a fundraising supper at the Inglisville hall, a fundraiser for the upkeep of the hall. On December 3rd, there will be 'Christmas in the Village' starting with lighting the tree at the Lawrencetown fire hall at 4, followed by fun at the arena.
- District 5 Councillor Heming noted he had helped arrange and also attended an economic conference in Miramichi. He thanked the Warden for his attendance and noted that two fishermen from District 5 also attended.
- District 9 Councillor Sheridan attended the Remembrance Day service at the Nictaux church. A soft opening for the Nictaux playground was held with lots of people there. She attended a Firettes craft fair on Sunday, which raised money matched by Scotiabank. The Lions Club held a turkey dinner on November 22nd along with a craft sale and tea.
- District 4 Councillor McNeil reported he had attended and laid wreath at Legion in Annapolis Royal, noting it was great to see all age groups in attendance, coming together. He noted the great orientation in Truro, where he gained lots of information, enjoyed the networking, and came home with lots to think about.
- District 7 Warden Habinski reported his attendance and participation at an October 27th fundraiser for the church in Tupperville to replace the roof –he read the Legend of Sleepy Hollow. He attended the conference in Miramichi, noting it was a very productive conference. He attended the Remembrance Day service with Councillor Fowler at the Bridgetown legion, and also the Annapolis Royal Volunteer

Fire Department awards dinner where presented long service awards. He noted the many intergenerational volunteers.

Re: East End Area LUB Zoning Map Amendment Application

MOTION 161115.06 East End Area LUB Zoning Map Amendment Application – 2nd and Final Reading

It was moved by Councillor Roberts, seconded by Councillor LeBlanc, that following the full consideration of the related goals, objectives and policies of the Annapolis County East End Area Municipal Planning Strategy, and upon receiving favorable recommendations from the East End Area Advisory Committee and the Annapolis County Planning Advisory Committee, and after holding a Public Hearing thereon, that Municipal Council give 2nd and Final reading of Council's intention to adopt the amendment to the Annapolis County East End Area Land Use By-law Zoning Map so as to rezone the property identified as PID Number 05186515, also known as the Falcourt Inn property, 8979 Highway 201, in the Community of Nictaux, from the present Rural (R-5) Zone to the Institutional (I) Zone, permitting the property to be converted from an Inn and Restaurant to an Addictions Rehabilitation Counselling Centre.
