It was moved by Councillor McDonald, seconded by Councillor Leblanc, in accordance with Section 22(2)(g) solicitor client privilege of the *Municipal Government Act*, to meet in-camera at 10:12 a.m. until 10:38 a.m. Motion carried unanimously.

Municipal Solicitor's Report

Re: Municipal Solicitor (August)

A report for the month of August was circulated in the agenda package.

It was moved by Councillor Chipman, seconded by Councillor Fowler, to receive the monthly report for information. Motion carried unanimously.

The Solicitor added that the costs for the Heritage Wooden Shingles appeal have been returned to us, and Mr. Clayton and his partner have stopped the residential use of that premises.

Councillor Comments

District 3 – Councillor Fowler reported the Port Lorne Planters were chosen as a successful winner of the contest sponsored by Vesey Seeds. They have received 1000 bulbs which will be planted in the shape of a Canadian flag for the 2017 150th celebrations.

Bridgetown – Councillor Hurlburt noted the privilege he felt to participate as a resident in a municipal election. While campaigning he meets a variety of people and learns about their concerns and local history. Concern – what affects their day to day activities? Surprises – discovering new residents, views and the depth of knowledge and experience held by many individuals. Proud to have this privilege.

District 11 - Councillor LeBlanc attended the Annapolis Valley Exhibition this year and noted the large amount of work done on the County booth. It was staffed by a lot of people and visited by lots more. She thanked Linda Bent for the work she did and wondered if she ever went home! She also thanked all other staff and councillors who participated. She also attended the opening tour at Mountain Lea Lodge and it was great to see the happy residents and care-givers with a great caring attitude.

District 6 – Councillor Morrison noted an area on the Waldec Line Road that used to be a gathering place but now has become a dump, an eyesore, a disgrace. Joe Lefebvre and his wife Ghislaine wanted the area cleaned up so it could be a source of wonder and joy again. They took action and worked with the surviving relative and with Grace Proszynska, the Valley Waste Resource Management By-Law

Enforcement Officer. Many hours over two days transformed the site. In addition to Ghislaine and Joe Lefebvre, he congratulated the main participants and hard workers: Nora and Judith Peach, Norma Vascotto, Daniel Scott, Dan Auby (owner and operator of the all-important back hoe), and Nancy Auby.

A number of months ago, the community placed benches that could be used for active transportation purposes as rest spots and that would persuade more folks to walk more. David Mason of Cornwallis Park made some placement suggestions. In time, through Council actions and the participation of the relevant NS government branch, the benches appeared and have met with resounding enthusiasm.

David Mason then turned his hand to the whole of Cornwallis Park, Deep Brook, Waldec and Upper Clements areas and drafted a strategic outlook document. This initiative on David's part has met with general approval and now future cooperative consultation steps are being considered. This is yet another example of the power of the individual in community matters.

The Cornwallis Community Gardens Association entered a Canada-wide contest sponsored, in part by the Canadian Garden Council with the support of Vesey's Seeds of PEI. The aim was to select gardens that would each receive 1,000 tulips (500 white and 500 red) and create a 150th Anniversary of Confederation Garden. They have been selected as one of ten recipients in Nova Scotia and the bulbs arrived yesterday. Work has begun to plan the many events that must be held by the winners. Significant to state 10 winners in Nova Scotia, two from Annapolis County!

- *District 9* Councillor Chipman noted the upcoming Nictaux Volunteer Fire Department annual yard sale on Saturday, and the October 6th ticket auction.
- District 7 Deputy Warden Habinski noted that Ciderfest was a tremendous success. It was a great decision to relocate to Jubilee Park, and the many volunteers are to be commended. A marvelous celebration. He joined staff member Debra Ryan in a cardboard boat and made it (only) to the first buoy! He encouraged all to attend next year.
- District 1 Councillor Wilkins, noted she was pleased to be acclaimed to serve residents of her district and the county as a whole. If one part of the County is doing well, it is all doing well. She thanked the residents for their faith in her to carry on.
- District 5 Councillor Heming noted his has been a quiet district, and it's been a wonderful year.
- District 4 Councillor McDonald commented on Alan Young, former owner of Fort Anne Café. He is not well. His daughter Janice is a municipal employee. Al has been a fixture in the community, a fire fighter, and busy community member. He asked that all keep him in their thoughts and prayers at this time, a true Nova Scotian and pillar of this community.
- District 10 Councillor Roberts thanked the 4H Council and groups that took good care of the 10 students and chaperones from Alberta. They went whale watching and showed off the Annapolis valley. They all had fun and have all returned safely home. She thanked the County for the pins provided.
- District 8 Warden Ritchie reported he was with MP Colin Fraser in Bear River where the MP announced funding for seniors activities \$40,380 to continue in Bear River. The Bear River Legion will receive \$15,380 for repairs to the roof, and Kejimkujik will receive \$3.9 million for upgrades. Kudos to the feds for these funding announcements. He also attended the Atlantic Mayors' Congress in Truro Sept 7-9 and will forward notes from that when available. MP Bill Casey and Dr. David Gray (Dal AG college campus) were a few of the speakers.

New Business

<u>Re: Municipal Elections Information Update</u> – It was noted that next Committee of the Whole is on Tuesday, October 11th, and it is an advance poll. The municipal administration building will be a polling station – a reminder that no campaign signage be located within 200 feet of the building. It was the consensus to receive the update for information.

She introduced Joyce d'Entremont, CED, who gave an update on the activities over the past few years, noting the follow areas:

Volunteers are always welcome! She added that they will celebrate 50 years with an Open House on October 22nd.

Ms. d'Entremont closed by noting there was an 'ask'. She requested that the Municipality strike a sub-committee to work with Mountain Lea Lodge in the infancy of their desire for a new building as noted in their strategic plan.

Warden Ritchie thanked her for bring a very informative update.

<u>Re: Southwest Nova Transition House Association – Juniper House (August 22nd) – in appreciation for the grant received which helps with services provided. Councillor Chipman moved, seconded by Councillor McDonald to receive for information. Motion carried unanimously.</u>

Re: Valley Hospice Foundation (August 26th) – reporting that construction will begin in 2017 on the new residential hospice for the Annapolis Valley located on the grounds of Valley Regional Hospital, with the Nova Scotia Health Authority funding its operations. The Valley Hospice Foundation was responsible to raise the funds for the construction. In 2013, Municipal Council committed \$270,000 over five years, with \$54,000 to be paid annually. They appreciated the two grants received so far and are requesting the third of five to be released.

Re: Trans County Transportation Society (September 9th) – in appreciation for continued support and for funds received which will assist in continuing to provide community-based, door-to-door, and accessible transportation options to the residents in Annapolis County. It was moved by Councillor Wilkins, seconded by Councillor Hurlburt, to receive for information. Motion carried unanimously.

Additions to the Agenda

Re: Water – Councillor Morrison noted he has been receiving information from residents of District Six regarding low water and wells. He started to explore how we can help those in need while respecting levels of authority and governments. He contacted Acadian Seaplants. Their water is not potable; they provide bottled drinking water for their employees. The Annapolis Basin Conference Centre noted that, if requested, help would be given. One family has received water assistance. He spoke with municipalities on south shore, noting to council that those municipalities are cooperating in alleviating the water shortage. He asked his district (by email) if there were any water issues, and received two replies. He was not sure further action is required, but is sure at the end of this drought, we need to consider how we can be prepared to meet another such event.

Several comments were added:

- We should anticipate more events of this nature
- One of the initiatives in our strategic plan is Clean Water
- Province should combine all 54 Climate Change Action Plans and come up with a master plan
- Clear cutting has had an impact on water retention

The CAO noted that our REMO is aware of the situation, as is the NS Emergency Management Organization. Some municipalities with great enough numbers of impacted residents have set up places for washing and showers. Private sectors have covered this so far. If the situation increases, we will plan further to determine what we can do.

Re: Annapolis County Trails Society (ACTS) – (email dated September 19, 2016) – of thanks for funding received for continuing development of the Annapolis County section of the Harvest Moon Trailway.

Work is ongoing at the Bridgetown Bridge and 4km of trail. Bloody Creek work will take place in the fall. A Letter of Authority was received for Tupperville to Annapolis Royal and the funds have been used to leverage an application for \$140,000 for seven bridges, 14 culverts, ditching and grading of 17 km. Councillor Fowler moved, seconded by Councillor LeBlanc, to receive for information. Motion carried unanimously.

Re: Transportation and Infrastructure Renewal – Cost Shared Subdivision Streets Fiscal 2017-18 Lists (dated August 31st) – requesting a prioritized list for consideration in cost-shared treatment (paving, repaving or double chip) of subdivision streets for fiscal 2017-18. It was moved by Councillor McDonald, seconded by Councillor Hurlburt, to refer to staff to have the list submitted no later than October 31, 2016. Motion carried unanimously. Any councillors wishing to have a street added should directly contact Director of Municipal Operations Stephen McInnis.
