

## Parcel Description – 207764

### Parcel A

ALL those certain tracks of land situate near or at Melvern Square, the Township of Wilmot, County of Annapolis and Province of Nova Scotia: (Morse Lands);

#### Lot No. 1

BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING at the Southwest corner of lands formerly occupied by Inglis Goucher, known as the Forest Glade lot;

THENCE Westerly along line of said Goucher lands a distance of 26 Rods, until it comes to the Southeast corner of lands formerly occupied by James Bowlby;

THENCE Northerly along the line of said Bowlby lands a distance of 44 rods until it comes to the south line of lands known as Edward Fales lands;

THENCE Easterly along said Fales line distance of 30 rods to said Goucher's West line;

THENCE Southerly along said Goucher line to the Place of Beginning.

### Lot No. 1

ALL that certain lot of land lying and being in Wilmot in the County of Annapolis and Province of Nova Scotia, bounded and described as follows:

BEGINNING at the North side of the Salem Road and on the East line of land formerly owned by the late Ambrose Dodge, marked by a stake and stones ;

THENCE North the true course of lines along the East line of said Ambrose Dodge to lands formerly owned by the late John Clark;

THENCE at right angles along said Clark's South line 50 rods to a stake and stones;

THENCE South the course of the lines along the West side of the School lot, so called, until it comes to within 80 rods of the above named Salem Road or to lands formerly owned by the late Charles B. Margeson;

THENCE South the course of lines until it comes within 3 feet where the said Charles B. Margeson's woodshop stood;

THENCE West at right angles 3 feet West of said shop;

THENCE South to the Salem Road;

### Lot No. 2

BEGINNING at a stake and stones on the North side on the Road leading from Melvern Square to the Spa Springs and at the Southwest corner of land the said Arthur Stronach formerly of the late Crawley Stronach;

THENCE Northerly the course of the lines 34 feet to a stake;

THENCE Easterly 30 feet;

THENCE Northerly along said Arthur Stronach's land to a state and stones standing 80 rods from the aforesaid road;

THENCE Easterly at right angles 20 rods to lands owned by Charles Morse;

THENCE Westerly at right angles 34 rods to a stake and stones;

THENCE Northerly the courses of lines 24 rods to the South line of the land of Clark;

THENCE Easterly by the said Clark's south line 34 rods to the Place of Beginning.
