District 1 – Councillor Parsons-Saltzman extended greetings from District 1. She mentioned that the Wilmont and Area Neighborhood Watch meetings are held on the first Monday of each month. She stated that at the last meeting a presentation was given on information regarding the Nova Scotia Guard which has approximately 2500 volunteers. Councillor Parsons-Saltzman noted that registration is now open for the four 4-H clubs within Annapolis County. She attended the Remembrance Day service at the NSCC in Middleton. She wished to thank all the volunteers within the County.

District 2 – Councillor Hare extended greetings from District 2. He encouraged residents to attend the Port George Jam Sessions held every Monday evening. He noted that they would be holding their last breakfast of the year in December and the AGM is scheduled for November 19, 2025, at 7:00 pm.

District 3 – Deputy Warden Enslow attended the Remembrance Day service in Bridgetown. He noted the Bridgetown Walk Program is held every Wednesday at 10:00 am. The walkers begin at the library and walk around the town. Deputy Warden Enslow stated that Friday, December 5, 2025, “Light Up the Town” would be held in Bridgetown. Councillor Longmire attended the Remembrance Day service at the Port Royal Legion, Annapolis Royal. She reminded residents to book their winter tire appointments. She encouraged everyone to stay safe and drive for the conditions.

District 6 – Councillor Welch noted that the past month has been both busy and rewarding across District 6. He met several residents on a range of local issues. He thanked everyone who reached out and welcomed him into their homes and businesses. Councillor Welch stated that one of the highlights this month was the official opening of the new comfort station in Bear River. He mentioned this makes the village waterfront more accessible, welcoming and better equipped to serve both residents and visitors. He commented that this represents the culmination of a longer journey to bring a reliable source of portable water to the Annapolis County side of Bear River. Councillor Welch attended the Bear River Fire Department breakfast. Although he could not attend the County Volunteer Ceremony, he expressed his appreciation to all the volunteers who make our communities work. He noted the great attendance at the Clementsport Historical Committee's AGM. He enjoyed the monthly beekeepers' meetings at the Upper Clements Hall. Councillor Welch attended a meeting of the Southwest Nova Biosphere Region Association. He met with Eric Todd from Nova Scotia Health to discuss the strengths, needs and challenges faced in District 6. Councillor Welch attended the Remembrance Day service in Bear River. He mentioned the Creatures of the Night event held on November 2, 2025. He encouraged residents to support local artisans during the upcoming holiday season.

District 7 – Councillor Agombar extended greetings from District 7. He felt honored to have served as councillor of District 7 for a full year now. He noted that the Nova Scotia Division 3 Girls High School Soccer Provincial Championship was held at the Bridgetown Sports Hub. He congratulated the Bridgetown girls on winning the bronze title. Councillor Agombar attended the Remembrance Day service at the Bridgetown Legion. He encouraged everyone to get out and support our local artisans at the many craft sales taking place within the County. He reminded residents to check the weekly activity calendar for the Bridgetown Legion as they host many events. He noted that on November 20, 2025 “Meet Your Chamber” would take place at the Bridgetown Legion at 6:30 pm. Councillor Agombar updated that the fall clean up at the Sports Hub has been completed. He mentioned that they have installed a solar power system in the new storage container.

District 8 – Councillor Harding extended greetings from District 8. He encouraged everyone to get their snow tires on and to drive according to the road conditions. Councillor Harding attended the Remembrance Day service at the Port Royal Legion, Annapolis Royal. He noted the service was well attended and thanked the dedicated volunteers. Councillor Harding also attended the official opening of the Bear River Comfort Station. He commented that the comfort station is a real asset to the community with two fully accessible washrooms, an outdoor covered desk / stage area, large washing sink and an outdoor shower.
